Social Director: Kathy Wyma thanked Mike & Connie Britz for organizing the fun June Drive N Dine. Art & Marilyn Ickes will be hosting the July Drive N Dine on the 19th. The meeting place will be the Quality Dairy on Saginaw, reservation deadline is July 12. Pat & Ellie Lickfeldt will be hosting the August Drive N Dine to Turkeyville on the 2nd. Money for dinner and theater tickets must be paid to Pat or Ellie by the end of the meeting. There will be a Cruise In on August 14 to Cones & Bones where you can have ice cream with your dog. August 16 is the date for the Speed Event at Spartan Speedway, and August 22-24 is Corvette Crossroads in Mackinaw City. Kathy reminded everyone to check the website for more details on these and other events. July Birthdays were recognized and celebrated.

<u>**Treasurer:**</u> Carol Putmon advised that all account balances were up to date and will be presented at the next Board Meeting.

Editor: Chris Burke advised that the deadline for the newsletter would be July 23. She still needs member profiles, even if you have submitted one before, updates would be appreciated. Chris advised that she would be sending an email to members notifying them that the newsletter is available on the website for viewing, rather than sending it as an attachment. 




