President John Bechtel called the meeting to order at 6:26 p.m. All board members were present.

Reports:

Secretary/Ambassador: Sandy Bechtel presented the minutes of the September 16, 2009 board meeting. Carol Putmon moved to approve them as written. Ed Politza seconded. Motion passed.

Points: Ted Lasher noted points are on the website. He also presented the final proposed language clarifications/changes to our points system. Ed Politza moved to accept them as proposed. Terry Burke seconded. Motion passed. The amendments will be proposed to the 2010 board for consideration/action.

Membership/Historian: Angela Hyde reported we currently have 114 regular, 1 honorary, and 70 Future Corvette Owners of America. She has already received 47 renewals, and noted all nominees have renewed.

Social: Sue Politza reported the following upcoming club events: October 23, Angela Hyde's Cruise-In; November 7, Bingo at Tamarack; November 14, Burke's Drive & Dine; December 2, Christmas party; and January 9, Winterfest.

Treasurer: Carol Putmon stated all bills have been paid under the current budget. She provided a list of all account balances.

Editor/Webmaster: No report.

Competition: No report.

Public Relations: Simon Reiffer stated he is working on 2010 newsletter advertising renewals. John Bechtel noted Mid America will advertise in any club's newsletter that includes advertising. Board discussion on whether or not advertising fees should be raised was ended without change.

Governor/Vice President: Terry Burke presented ballots for the upcoming NCCC elections. The slate of nominees was reviewed and decided on. After discussion, we voted no on a potential NCCC bylaw change regarding youth membership. We voted yes on 2011's national convention venue of Tinley Park, Illinois. Convention dates are June 18-24, 2011. The Midwest Region will be hosting the convention.

President: John Bechtel noted that because B & B Embroidery has relocated to Texas, we will have to update club apparel information on our website. All available replacement services were discussed.

Old Business: John Bechtel indicated the budget committee recently met to develop a 2010 budget to propose to the incoming board. Proposed numbers will not be finalized until after the November general membership meeting, so we can have a more accurate membership renewal count. One of the budget items is updated website software. Gloria stated she is still waiting for final price information from Microsoft. A \$25.00 annual Flickr subscription (picture storage) was also discussed, because it would free up space on our website. (Members wishing to view pictures on our website will not notice this technical change.) Ed Politza moved to subscribe now. Terry Burke seconded. Motion passed. Ted Lasher agreed to follow up on this.

New Business: John Bechtel indicated we need to select a committee to handle our holiday donations. (We have a budget of \$900.00.) Last year, the membership voted to increase that amount to \$1,500.00, and donated \$500.00 to each of the follow organizations: VFW National Home for Children, American Red Cross, Lansing Food Bank. John will ask for committee volunteers at the November general membership meeting. Ted Lasher presented a proposed standard flyer for club events. It will be available to members who are organizing a club event.

Adjournment: Simon Reiffer moved to adjourn. Sue Politza seconded. Motion passed. Meeting adjourned at 7:55 p.m.
